# General

The WeTrade 8th Anniversary Bonus Terms and Conditions will take effect from August 01, 2023. By participating or continuing to participate after the effective date, you agree to the following:

The information below forms the basis for participating in the WeTrade 8th Anniversary Bonus ("Bonus"). These Terms and Conditions ("Terms and Conditions") are intended to protect WeTrade clients ("clients"). Your participation in this campaign will be subject to these Terms and Conditions, and you are responsible for reading and understanding all of the terms and conditions.

# Terms

**Trading Volume:** Trading volume refers to the actual number of trades placed by clients on the platform for forex trading or other financial products.

**Standard Lot:** Trading volume is typically measured in standard lots, where one standard lot equals 100,000 units of the base currency.

**Net Deposit:** Net deposit is the net amount of money deposited by the client during the campaign period. It is calculated by determining the difference between the total amount of funds deposited into the account (total deposits) and the total amount of funds withdrawn from the account (total withdrawals) within a specified time frame. This difference can be either positive or negative.



# Campaign Details and Conditions

**Participants:** All new and existing clients of WeTrade.

**Campaign Period:** Deposits and withdrawals will be counted starting from August 1, 2023, at 0:00 (GMT+3) server time until August 31, 2023, at 24:00 (GMT+3) server time. Trading volume will be counted starting from August 1, 2023, at 0:00 (GMT+3) server time until September 16, 2023, at 0:00 (GMT+3) server time.

**Campaign Details:** Throughout the campaign period, clients who meet both the corresponding net deposit and trading volume requirements will qualify to receive the corresponding USD bonus rewards. The specific bonus scheme is outlined as follows:

According to the total net deposit and trading volume levels achieved, clients will qualify to receive varying levels of USD bonus rewards.

The bonus will be added to the client's wallet account within 3 working days after the campaign ends, which means before September 20, 2023. Clients have the option to withdraw the funds directly (subject to meeting the minimum withdrawal requirements) or transfer them to their trading account for further trading, or keep them in the WeTrade wallet to earn more points rewards.

# Campaign Details and Conditions

1. Deposits, withdrawals, and trading volume made by clients in their own named accounts will be considered as valid net deposit and trading volume for the campaign.
2. USDT top up and IB transfer deposit method are not eligible for this campaign
3. Internal transfers are not considered as deposits.
4. In the cent account, trading volume is calculated in cents, and 1 cent lot is equivalent to an accumulated 0.01 standard lot.
5. Trading of indices, cryptocurrencies, and stocks are not eligible for this campaign.
6. To qualify for the bonus, clients must meet both the net deposit and trading volume targets simultaneously, and the final reward level will be determined by whichever level is reached first.
7. WeTrade reserves the right to disqualify users who violate the campaign rules or abuse the bonus.
