

Swap Free Campaign Terms and Conditions



General

Effective from 12th, June ,2023. The following supersedes all prior Terms & Conditions. By participating or continuing to participate after the effective date, you agree to the following:

These terms and conditions (the "Agreement") govern the participation in the Swap-Free Period (the "Campaign") offered by WeTrade (the "Company") to its clients (the "Clients"). By participating in the Campaign, Clients agree to be bound by the terms and conditions set forth herein.

Terms&Conditions

Eligibility:

- A. The Campaign is open to all new and existing Clients of the Company.
- B. The Campaign applies to trading in Metals and Forex only (USDJPY, AUDJPY, CADJPY, CHFJPY ,EURJPY, GBPJPY, NZDJPY not applicable).

Campaign Period:

- A. During the Campaign, Clients will receive a 7-day swap-free and an additional 7-day discounted swap period for forex.
- B. During the Campaign, Clients will receive 7-day discounted swap period for metal instruments.

免息或优惠利息期结束后的费用:

外汇产品（特定货币除外）：

A：在7天免息期后，将按照MetaTrader 4（MT4）平台上公布的利息费用的一半收取费用，直到第14天。

B：在第14天优惠利息期结束后，将按照MT4平台上公布的利息费用的全部金额收取费用。

贵金属产品：

A：在14天优惠利息期结束后，将按照MT4平台上公布的利息费用的全部金额收取费用。

Charges after the Swap-Free Period:

A: Forex

- 1. After the 7-day swap-free period, Clients will be charged half the advertised swaps in the MetaTrader 4 (MT4) platform until the 14th day.
- 2. After the 14th day, Clients will be charged the full amount of the MT4 swap charges.

Metals

After the 14th day of discounted swap period, Clients will be charged the full amount of the MT4 swap charges.

- C. The swap charges are calculated based on the interest rate differentials between the two currencies involved in the trade.
- D. The swap charges are subject to change in accordance with market conditions and at the discretion of the Company.
- E. Swaps will be charged between 23:55 and 23:59 (server time) .

Client Responsibilities:

- A. Clients must monitor their trades and be aware of any applicable swap charges.
- B. Clients are responsible for managing their trades and any associated risks.

Campaign Modification or Termination:

- A. The Company reserves the right to modify or terminate the Campaign at any time without prior notice.

Terms&Conditions

Risk Disclosure:

- A. Clients acknowledge that trading in Metals and Forex involves a high level of risk and may not be suitable for all investors.
- B. Clients are advised to seek independent financial advice before participating in the Campaign or engaging in trading activities.
- C. Due to MT4 technicality, a partial closure is considered a new trade therefore the new trade will be subject to all T&C.

Limitation of Liability:

- A. The Company shall not be liable for any losses, damages, or costs incurred by Clients as a result of their participation in the Campaign.
- B. Clients participate in the Campaign at their own risk.
